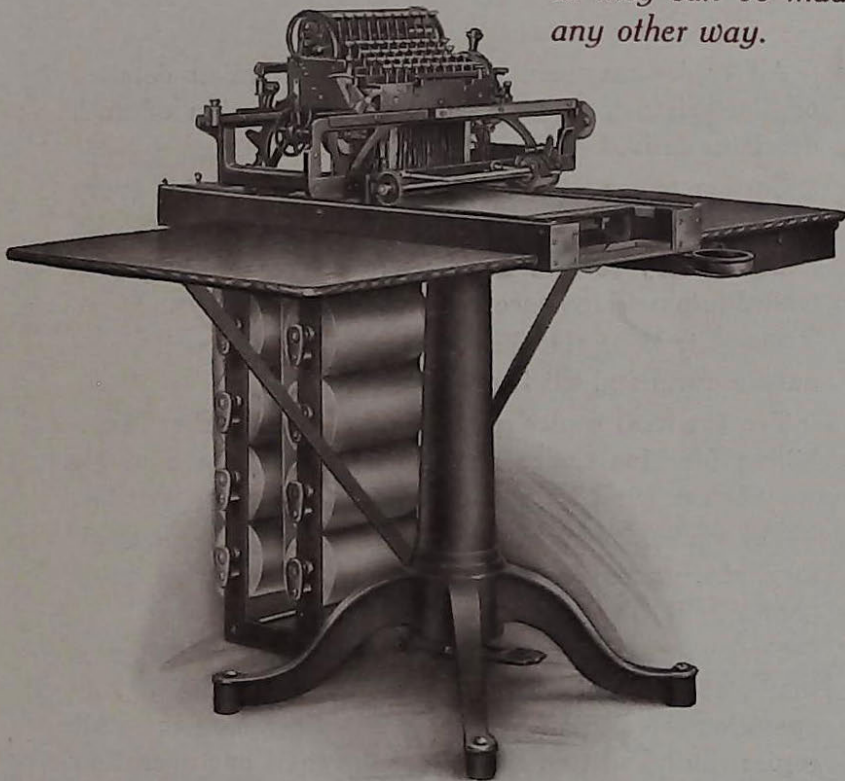

Elliott-Fisher Manibilling Machine

ONE of the greatest time savers ever designed for use in Order Departments, Shipping Rooms, Billing Offices, etc.

Makes from two to ten legible copies at one writing.

All copies may contain all the information detailed on the original, or may carry only a portion of such detail, as desired.

Carbon paper need be adjusted once only for every 100 or more sets of forms written.

Rolls carry several hundred forms so that paper is loaded into machine once every two or three days.

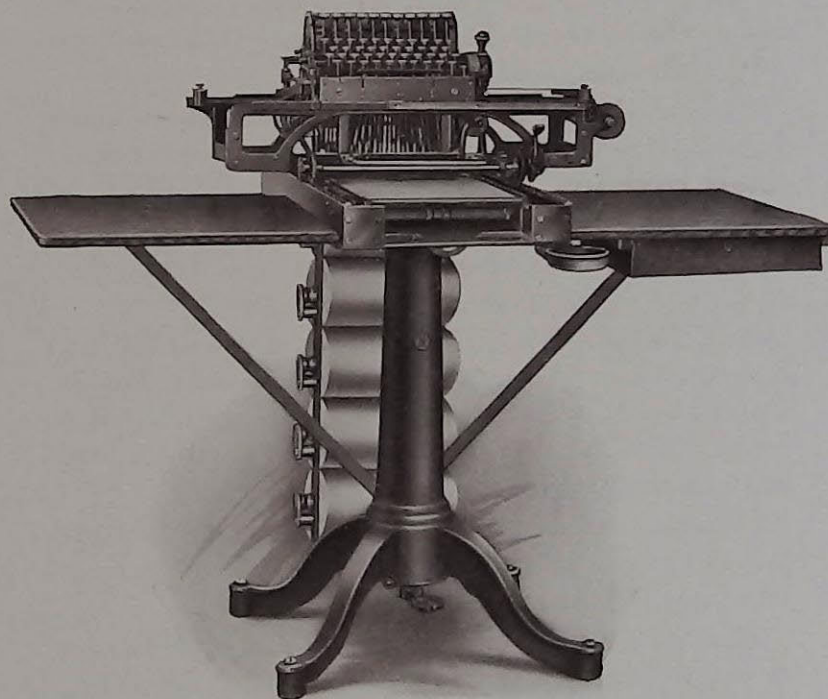
The only thing the operator has to do is to write, pull out the form and cut it off.

Ten (or less) copies are made on Elliott-Fisher Manibilling Machine easier and much faster than a single copy can possibly be written on an ordinary typewriter.

The ten copies may all be printed with different headings, etc., or may be had on different tints or colors of paper.

Various work now performed by slow, uncertain methods, at different operations, may be combined in one operation on Elliott-Fisher Manibilling Machine—All copies can be written easier and faster at one operation on Elliott-Fisher Manibilling Machine than any part thereof can be written separately any other way.

When several copies are made at one writing, each copy is an exact duplicate of that portion of the original de-

sired upon it. Thus eliminating the useless checking to avoid or locate errors, always necessary where the same work is done in separate operations.

The efficiency and saving in making multiple copies on Elliott-Fisher Manibilling Machine, are simply marvelous.

The great saving of time, effort and expense which Elliott-Fisher Manibilling Machine effects on multiple copy work is only half of the story.

On many kinds of Order work there is detail to be added on each Order and a total of all Orders entered is desirable or necessary.

Elliott-Fisher does all the adding in as many columns as wanted, automatically as it writes, with no extra effort on the part of the operator.

As Elliott-Fisher adds the figures it writes, at the time it writes them, in Order work, so does it handle all additions and subtractions on any kind of Billing where it is desired to get totals of each individual Bill and the total of all Billing for the day, week or month.

Orders, Bills, etc., which are added as written are proved as made out and are ready for mailing as soon as they come from the machine.

Think of the speed and economy of making ten copies at one writing, the accuracy of having all the adding desired on each Bill or Order done at the same operation, and of the convenience and proof in knowing at the end of the run, the total of all Bills or Orders made.

Contrast this one simple, easy, rapid operation on Elliott-Fisher Manibilling Machine with the writing of a lot of copies all at separate operations, then the necessity of checking all copies to see that they all contain the right detail, and then at another operation adding each Bill, Order, etc., and, finally, if a total of all Bills or Orders is

wanted, the totals as shown by each Bill or Order must be added at still another operation.

Estimate the effectiveness of doing in one operation on Elliott-Fisher Manibilling Machine work which must be done in from three to a dozen operations any other way and you estimate the elimination of worry, work, wasted effort, time and money—the answer is efficiency.

Elliott-Fisher Manibilling Machines are made in two sizes—The No. 5 Manibilling Machine (illustrated on Page 3) with a maximum capacity for 5 copies from continuous roll forms. One or two loose cut forms may, for certain requirements, also be made at the same writing. Any less number of copies desired may be made. The No. 10 Manibilling Machine (illustrated on the first page) with a maximum capacity of 10 copies from continuous roll forms. One or two loose cut forms may, for certain requirements, also be made at the same writing. Any number of copies less than the full capacity of the machine may be made.

Both No. 5 and No. 10 Elliott-Fisher Manibilling Machines use printed or plain forms from rolls exactly $8\frac{1}{2}$ inches wide—This is the standard width form for 95% of business requirements, and the standard width for economy in stationery. The forms cannot vary a sixteenth of an inch either over or under $8\frac{1}{2}$ inches in width for satisfactory work. Forms may be any length from $2\frac{2}{3}$ inches to 12 inches, but the standard length is $5\frac{1}{2}$ or $7\frac{1}{3}$ inches, and should be adhered to wherever possible.

The writing space on the form can be any depth up to 9 inches by $8\frac{1}{2}$ inches in width.

The illustration on Pages 6 and 7 are exact size of standard form $7\frac{1}{3}$ " deep x $8\frac{1}{2}$ " wide, and, as will be seen, provide ample room for the writing of detail for most purposes.

Carbon paper 11" wide is used. For forms 5½" deep, carbon paper 5 x 11 would be the proper size, for forms 7 1/3" deep, carbon paper 7 x 11 is indicated. The better the grade of carbon paper used, the less handling of carbon paper is required. Common carbon paper will give 20 to 40 imprints, while Elliott-Fisher carbon No. 5053 will give from 100 to 125 clear, sharp imprints that are easily read.

All forms are arranged in accurate registration in a simple manner.

The illustration of the work done on Elliott-Fisher Manibiller shown on pages 6 and 7 is a facsimile of actual work. The smaller illustrations on pages 5, 9 and 11 show reduced copies of a portion of full sized copies similar to those shown on pages 6 and 7. In order to illustrate how part or all of the detail on the original may appear on the copies, the sales or statistical sheet illustrated on page 5 contains all of the information of the original, shown on pages 6 and 7, while the express receipt shown on page 9 contains only the information required for an express receipt. On page 11 is shown another form containing only the items and the identifying number, such as might be used for a departmental order, or instruction to Purchasing Department to buy certain goods, when for any reason it is necessary or desirable to withhold the name and address from any department or from outsiders.

The original might be an Invoice, second copy a Charge Sheet, third copy Sales Sheet, fourth copy Statistical Sheet, fifth copy Express Label, sixth copy Express Receipt or uniform Bill of Lading, seventh copy, Pre-paid Express Voucher, and as many as three extra copies for any purpose desired.

The original might be a Bill of Lading—two to four copies of the Bill, Shipping Label, etc., or second copy

might be an Express Receipt, third copy Prepaid Express Voucher, fourth copy Shipping Label and as many as six extra copies for any purposes desired.

The original might be a Shipping Order, second copy Acknowledgment of Order, third copy Office Copy, fourth copy Express Receipt or uniform Bill of Lading, fifth copy Prepaid Express Voucher, or copy of Bill of Lading, sixth copy Shipping Label, seventh copy Shipping Room copy and three copies for Departmental Orders or any other purpose desired.

The United States appraiser at an important port uses Elliott-Fisher Manibilling Machines in a method for clearing goods imported from abroad—Deliveries are now made in 48 hours where previously it required 3 to 6 weeks time to get goods through the Customs.

A steamship line uses Elliott-Fisher Manibilling Machines for billing shipments.
